FEMA related grant programs

Emergency Management Performance Grants (EMPG)

The purpose of EMPG is to provide federal grants to states to assist state, local, territorial, and tribal governments in preparing for all hazards, as authorized by the Robert T. Stafford Disaster Relief and Emergency Assistance Act (Stafford Act).

Port Security Grant Program (PSGP)

The PSGP is one of four grant programs that constitute DHS/FEMA's focus on transportation infrastructure security activities with priorities on enhancing protection of soft targets and crowded places. Everbridge's solutions can help physically secure a location and provide life-saving alerts in those areas.

State Homeland Security Program (SHSP)

The SHSP assists state, tribal, and local preparedness activities that address high-priority preparedness gaps across all core capabilities and mission areas that support terrorism preparedness.

Urban Areas Strategic Initiative Program (UASI)

The UASI program assists high-threat, high-density urban areas in efforts to build and sustain the capabilities necessary to prevent, protect against, mitigate, respond to, and recover from acts of terrorism.

Operation Stonegarden (OSPG) Programs

The OPSG program supports enhanced cooperation and coordination among Customs and Border Protection (CBP), United States Border Patrol (USBP), and local, tribal, territorial, state, and federal law enforcement agencies.

Hazard Mitigation Grant Program (HMGP)

The purpose of HMGP is to help communities implement hazard mitigation measures following a presidential major disaster declaration in the areas of the state, tribe, or territory requested by the governor or tribal executive. The key purpose of this grant program is to enact mitigation measures that reduce the risk of loss of life and property from future disasters.

Transit Security Grant Program (TSGP)

Transit Security Grant Program (TSGP) provides funds to eligible publicly owned operators of public transportation systems (which include intra-city bus, commuter bus, ferries, and all forms of passenger rail) to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of transit infrastructure.

Pre-Disaster Mitigation Grant Program (PDM)

The PDM program, authorized by Section 203 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, is designed to assist states, U.S. territories, federally recognized tribes, and local communities in implementing a sustained pre-disaster natural hazard mitigation program. The goal is to reduce overall risk to the population and structures from future hazard events, while also reducing reliance on federal funding in future disasters.

Flood Mitigation Assistance Grant Program (FMA)

FMA provides funding to states, territories, federally recognized tribes and local communities for projects and planning that reduces or eliminates long-term risk of flood damage to structures insured under the NFIP.

State Homeland Security Program (SHSP)

The SHSP assists state, tribal, and local preparedness activities that address high-priority preparedness gaps across all core capabilities and mission areas that support terrorism preparedness.

Assistance to Firefighters Grants (AFG)

AFGs provide financial assistance directly to fire departments and nonaffiliated EMS organizations to enhance their capabilities with respect to fire and fire-related hazards. Its primary goal is to help fire departments and nonaffiliated EMS organizations meet their firefighting and emergency-response needs.

Tribal Homeland Security Grant Program (THSGP)

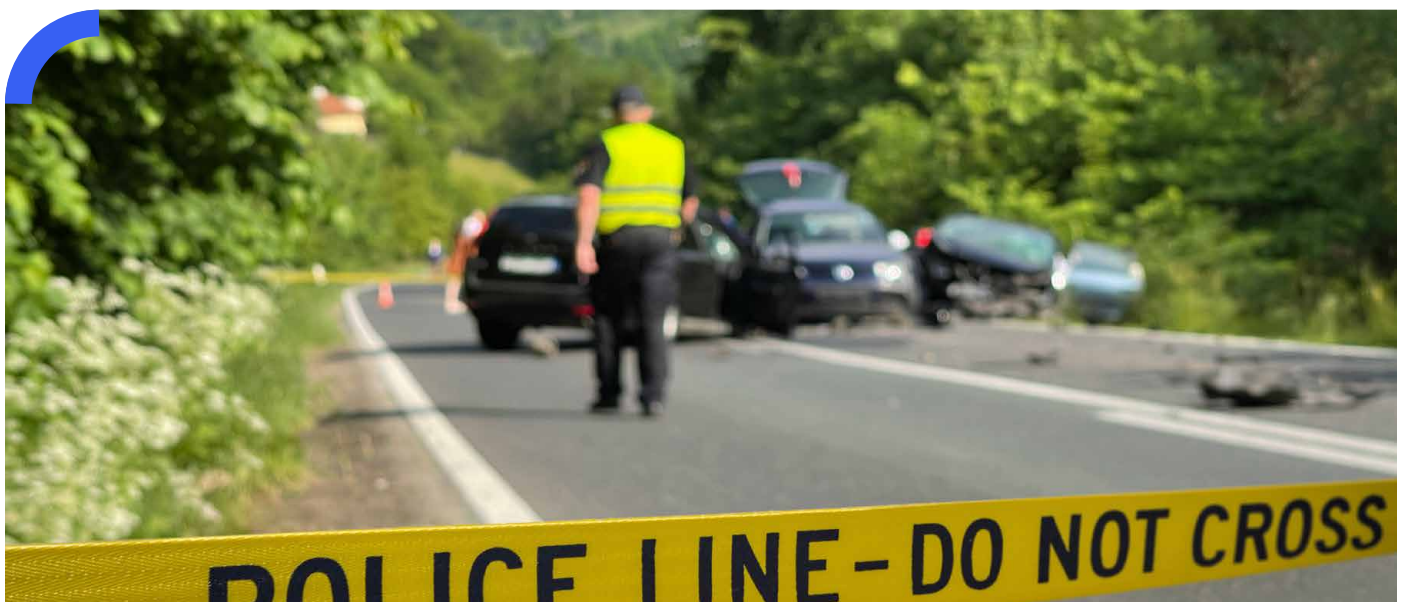
The THSGP is one tool among a comprehensive set of initiatives authorized by congress and implemented by the administration to help strengthen the nation against risks associated with potential terrorist attacks. THSGP supports the building, sustainment, and delivery of core capabilities to enable tribes to strengthen their capacity to prevent, protect against, mitigate, respond to, and recover from potential terrorist attacks and other hazards.
