

# **Everbridge Sub-processors** (Revision: November 14, 2025)

Pursuant to its agreements, Everbridge, Inc. (together with its subsidiaries and affiliates, "Everbridge") uses sub-processors to deliver its products and services. As part of its provision of services, Everbridge's Critical Event Management Platform will send alerts and messages at each customer's direction to identified recipients using standard protocols (such as email, SMS) or customer-controlled communications channels (such as Slack, Teams, social media), wherever recipients are in the world. This means that the messages will transit and be routed through telecommunications providers globally to reach the devices of designated end recipients.

Everbridge cannot predict where a particular recipient will travel or how messages will be routed over networks, so it cannot predict what telecommunications providers might process messages to recipients. Potential telecommunications providers appear below under "Available Communication Delivery Channels."
